#### **Overview**

The Division of Clinical Therapeutics focuses on clinical research of non-psychotic psychiatric disorders on adults. This division is comprised of six sub-units: Anxiety Disorders Clinic, Anxiety Genetics Unit, Clinical Psychobiology/Biological Studies Unit, Center for Neuroinflammatory Disorders and Biobehavioral Medicine/ Lyme Disease, Depression Evaluation Service and the Eating Disorders Research Unit.

Current investigations include treatment of unipolar and bipolar depressive disorders, of a range of anxiety disorders and eating disorders, of hypochondriasis, of psychiatric symptoms following Lyme disease, and of fatigue associated with HIV.

A variety of techniques are being applied to uncover psychological, biological, genetic, and environmental factors that contribute to the development and persistence of these serious psychiatric problems. These include brain imagining, molecular genetics, and neuropsychological assessment. Treatment trials using both medication and psychotherapy are underway in each of these areas as part of a world-renowned research program; there is no charge to research participants.

#### **Current Research**

The research in Clinical Therapeutics centers on the psychobiology and treatment of Anxiety, Mood and Eating Disorders and related conditions in adults.
